Sunny Hill Preschool Tuition Policies

- Tuition may be paid in a single payment, quarterly payments or in monthly installments. Payments are due the first day of each month, according to the payment schedule you have selected.
- The first tuition payment of the school year will be due on October 1, 2010.
- If more than one child of the same family is enrolled in a preschool program, a tuition discount of 20% is given on the lesser tuition amount.
- Scholarships are available on a confidential basis. Please contact the Director if you would like further information about scholarships.
- In addition to the non-refundable registration fee of \$50 made at the time of application, a deposit of at least one monthly installment is required By January 15, 2009 in order to guarantee your child a place in the program for the 2010-2011 school year.
- The tuition deposit will be refunded to parents who give written notice they are withdrawing their child from the program on or before April 1, 2010. Refunds for children who are withdrawn after that date are not automatic, and will be determined on a case by case basis by the Sunny Hill Committee.
- If a child is withdrawn during the school year at the request of the parents, the school must receive at least two weeks notice.
